RISK STATEMENT

Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By allowing the child mentioned above to participate in the event I, the parent/guardian of the child, agree and acknowledge that:

- 1. I am aware of the inherent element of risk involved in the sport and accept responsibility for exposing my child to such inherent risks;
- 2. I have satisfied myself that my child has the necessary skill and knowledge to participate in the event and to deal with conditions that may arise in the course of a race;
- 3. I will not allow my child to participate in the event whilst they are under the undue influence of alcohol, drugs or whilst otherwise unfit to participate;
- 4. I am responsible for ensuring that the boat on which my child is sailing is in good order, equipped and insured (including third party insurance as required by the Notice of Race of the event);
- 5. I am responsible for my child's property whether afloat or ashore;
- 6. I accept responsibility for any injury, damage or loss to the extent caused by my own actions or omissions or actions or omissions of my child;
- 7. The provision of a race management team, patrol boats, umpires and other officials and volunteers by the Organizing Authority does not relieve me of my parental/guardianship responsibilities or my child of his/her responsibilities;
- 8. It is my responsibility to familiarize myself and my child with any risks specific to this venue or this event drawn to our attention in any rules and information produced for the venue or event and to attend any safety briefing held for the event;
- 9. The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances.

ACCEPTANCE OF THE RULES

In addition, by allowing the child mentioned above to participate in the event, I, the parent/guardian of the child, and the person nominated below to act as supervising person (where applicable), agree and acknowledge that:

- 1. We, and my child, are bound by the rules as defined in the Racing Rules of Sailing (RRS) and all other rules that govern this event;
- 2. There is an obligation to ensure that my child's support persons (as defined in the RRS) comply with the rules, and that my child's boat could in certain situations be penalized if any of my child's support persons do not comply with the rules.
- 3. My child may be required to participate in drug testing procedures and provide a urine sample under observation for analysis at an accredited laboratory.

MEDICAL CONSENT

Herewith, by allowing the child mentioned above to participate in the event, I, the parent/guardian of the child, authorize the Organizing Authority of the event to make any medical or hospital arrangements for my child in case of emergency, including his/her transport to hospital.
